This is a much belated response to Bill Dzurilla's e-mail of 12 October 2007 and I apologise for this delay.

We had made a proposal regarding the financial aspects of this matter in our letter of 25 September 2007, *i.e.* that our fees should be covered either by an advance payment or by your firm. That offer seemed to us to be reasonable.

As you indicate, however, neither of these solutions appears to be possible and we would have to deal with US bankruptcy proceedings to have our statements of costs approved.

Considering the above, we have come to the conclusion, regrettably, that we will have to withdraw from the arbitration.

As a result, you may want to consider whether you should inform the Arbitral Tribunal of our withdrawal or whether you prefer that we should write. In the latter case we could let you have our letter in draft form.
